If artwork needs to be touched up or manipulated in any way, art charges will be incurred. These charges will be acknowledged before proceeding with the order. Artwork that requires changes may add additional time to production. Graphic services will be billed at \$50.25(v) per hour.

PURCHASE ORDERS
